APS PREMEETING ADVERTISING OPPORTUNITY APPLICATION

WEBINAR (\$2,500)

Host a 60-minute live and on-demand webcast or podcast with Q&A.

Only one webinar slot available for purchase. Topic must be approved by APS by January 31, 2018.

DIRECT MAIL (\$500)

- Promote your presence before attendees decide which companies to visit in the exhibit hall.
- Begin your sales process early and enhance your return on investment.
- Reach preregistered attendees with a list provided 30 days before the meeting.
