Rules and Regulations

Town Hall Talks are assigned on a first-come, first-served basis pending APS approval. The showcase fee is **\$7,500** and must accompany your completed Town Hall Talk application. Town Hall Talks are only available to those who purchase an exhibit booth. The fee includes space rental and listing on onsite signage that features **all** Town Hall Talks. Titles will be listed in the APS Program Book. Descriptive copy (50-word limit) must be sent to jmaginot@americanpainsociety.org by March 31, 2017.

All activities are restricted to the designated area in the Experience Exchange at the Austin Convention Center. You will be responsible for organizing your presentation. The area will be set up in theater style for 50 attendees and will include an LCD projector/screen, podium, microphone, and one lead retrieval machine. You are responsible for any special-need charges (e.g., catering, additional audiovisual equipment, etc.).

Please note that, per convention center policy, no outside food or beverages are allowed at any meeting function.

Promotion or notification of your program is your responsibility. You may place a sign no larger than 28" x 44" in the registration area, at the entrance of the exhibit hall, and outside the designated area 24 hours before your program is scheduled to begin. You may promote your showcase through direct mail, room drop, or program book advertising for an additional fee.

Sessions are approved after **submission of the Town Hall Talks application form** on a first-come, first-served basis. No cancellations are accepted after space is confirmed.
